This general list is not disclosed to third parties. Candidates are sent this form requesting their details, including their personal details, expertise, experience, availability and language skills. The form is to be returned and accompanied by a curriculum vitae. The Board decides which candidates to provisionally place on the general list. The final decision is made after control or when candidates have followed the basic course of EMTPJ (AIA - Brussels) or ERA (Their - Germany).
